This agreement is by and between New Jerusalem Gifts Inc. and all subscribers. You understand that New Jerusalem Gifts Inc. does not guarantee or predict any type of profit other than 10% commission on referred customer purchases.

Services to be Provided

We will be responsible for providing information necessary to allow you to make appropriate links to our website.

We will be responsible for tracking the amount of sales generated by your website and for making this information available to you.

We agree to pay you 10% commission for referral sales made by customers. Payments totaling \$25 or more will be sent by check or PayPal account approximately 15 days following the end of the month.

Terms
